2. Community/Government Reports & Announcements

- a. **Dave Brown**, Southern California Preparedness Foundation
 - Valley Disaster Fair will take place on Sunday, September 29. Free emergency kits will be given to the first 2,000 attendees.
- b. Jenny Portillo, Field Deputy, Bob Blumenfield's Office
 - On August 29, LADOT will give a presentation on the current status of parking issues in Canoga Park and possible solutions.
- c. **Erin Schneider**, *West Valley/Mt. Communities Field Deputy for Sheila Kuehl*, Bridge housing is still in the proposal phase, and input from the community is needed. More events are planned to discuss housing proposals and to engage the community in dialogue about the issue. - d. **Jose Moreno**, *SLO*, *Topanga Station*, Continue to safeguard property to prevent crime; 20 property crimes were reported in the area last week. Tip a Cop event will be hosted by California Pizza Kitchen at the Topanga Canyon Mall on October 18, from 5 to 9 pm. A percentage of the proceeds will go to the Special Olympics. The Community Patrol program has enlisted the first set of volunteers. If you're interested, stop by the Topanga Station for an application.
- e. Vanessa Serano, DONE, Ignite LA is accepting applications from women aged 14 to 24 years who are interested in political leadership. The Funding Department has made updates to its policies and guidelines, which are available on the City Clerk's website. New copy of bylaws was sent out, which includes a new, clear map of the council's boundaries (no changes were made to actual boundaries). City Clerk will be contacting the neighborhood council Election Committee chair, who will serve as a liaison to work directly with the Elections admin. Board Members should be sure to keep their Ethics training up to date. The Congress of Neighborhoods is coming up (September 22). - Debbie Skilken, Warner Center Condos: Expressing opposition to proposed apartment building on Alabama Street; concerns about traffic/congestion
- Lena Ayvazian, Warner Gardens HOA, Expressing opposition to proposed apartment building on Alabama Street; concerns about priority given to rental properties rather than ownership; lack of infrastructure to support additional housing units
- Steve Slutzah, Westside Tile and Stone, Expressing concerns about proposed Bridge Housing at 7621 Canoga Ave; there are many parking and security issues, need a better solution
- Jeff Goodman, Warner Gardens HOA, Expressing opposition to proposed apartment building on Alabama Street; demolition will cause release of carcinogens and health issues; traffic study should be requested for surrounding area
